THE CONVEYANCE IN 1943 FROM McCREAGH & THE PUBLIC TRUSTEE TO THE WAR DEPARTMENT OF FREEHOLD LAND IN BARTON STACEY PARISH.

BACKGROUND

This extensive tract of land, covering about two-thirds of the parish of Barton Stacey, descended to the McCreagh family from the Wright Wilsons and before them the Wright family who owned the land back to the 17th century. Details of the transfers of this land can be found in a piece on the Drayton Lodge Estate elsewhere on this website.

By the time of the second World War the land was much neglected and was requisitioned by the army. Then in 1943 it was sold by McCreagh to the War Department.

THE DETAILS OF LAND ACQUIRED

This is laid out farm by farm and includes acreages of all fields and properties. For convenience here, the plan has been enlarged in sections.

This includes land designated in 1962 to Hampshire County Council for the use of the public.

THIS CONVEYANCE made this 16th day of June 1943

<u>BETWEEN MICHAEL CHRISTOPHER WRIGHT MCCREAGH</u> of No 32 Victoria Street in the County of London, barrister at law (hereinafter called "the vendor") of the first part

THE PUBLIC TRUSTEE of the Public Trustee Office, Kingsway in the County of London (hereinafter called "the trustee") of the second part

and <u>HIS MAJESTY'S PRINCIPAL SECRETARY OF STATE FOR THE WAR DEPARTMENT</u> (hereinafter called "The Secretary of State") of the third part

WHEREAS:

- A. The property hereinafter described is settled land within the meaning of the Settled Land Act 1925 (hereinafter referred to as the said Act) and the legal estate in such property has by an appropriate vesting instrument been duly declared to be vested in the vendor or in fee simple upon the trusts of a settlement affecting the said property and therein referred to and accordingly the vendor has and can exercise over the said property the powers of a tenant for life under the said Act.
- B. The Trustee is trustee for **the purposes of the said Act** of the said Settlement as is stated by the said vesting instrument.
- C. By an order of the Chancery division of the High Court of Justice made on the 28th day of August 1940 by the Honourable Mr Justice Bennett, in the matter of the Drayton Lodge Estate situate in the parishes of Barton Stacey and Wonston in the County of Southhampton settled by an indenture dated the fifth day of February 1906 and made between Eva Helen Emma McCreagh Thornhill of the one part and Henry Bruce Armstrong and William Francis Farrer of the other part and, in the manner of the said act (1940 T. No. 637) it was (amongst other things) ordered that the Trustee as trustee of the said settlement was at liberty during the remainder of the life of the vendor or until further order in his name and on his behalf to exercise the power of sale conferred by the said act in relation to all or any part of the land comprised in the settlement created by the said indenture, the possession or acquisition of which had been or might be required by any authority (being a competent authority within the meaning of the Defence (General) Regulations 1939), and that the vendor should forthwith deliver up to the trustee all documents of title in his possession relating to the said land
- D. The Secretary of State being the competent authority within the meaning of the Defence (General)

 Regulations 1939 requires to take and has taken possession of the property hereinafter described for the purposes of the defence of the realm.
- E. The Trustee acting on behalf of the vendor under the said order has agreed to sell and the Secretary of State in exercise of his statutory and other powers has agreed to purchase the said property and the fee simple thereof in possession free from encumbrances at the price of £24,000.

NOW THIS DEED WITNESSETH AS FOLLOWS:

In pursuance of the said agreement and in consideration of the sum of £24,000 on or before the execution of this deed paid by the Secretary of State to the trustee as such trustee as aforesaid (the receipt of which sums the trustee hereby acknowledges) the vendor acting by the trustee in his name and on his behalf in exercise of the power for that purpose, deferred on him by the said order and the said act and of all other powers and as trustee

HEREBY CONVEYS unto the Secretary of State

ALL THOSE pieces of land containing 2106.556 acres or thereabouts situate in the Parish of Barton Stacey in the County of Southampton delineated (for limitation) on the plan hereto annexed and thereon coloured pink and are more particularly described in the First Schedule hereto

Together with all timber thereon and the buildings erected thereon or on some part thereof

TO HOLD unto the Secretary of State and his successors for ever for a legal estate in fee simple absolute in possession on behalf of His Majesty

SUBJECT to and with the benefit of such of the leases and tenancies affecting the said property as still subsist and DISCHARGED as provided by Section 72 of the Settled Land Act 1925.




DRAYTON PUMP FARM

MEMORANDUM

In 1950 an adverse claim to O.S. No. 43 in the Parish of Barton Stacey was put forward on behalf of Capt. A.S. Wills and considered under W.O. File No. LB/BM/196/50 and T.S. Reference W.O. 1/34858/RRC. From Corbould Rigby & Co's letter to the T.S. dated 16 Nov 1950 it appeared that Capt. Wills had a better title to the said O.S. No. than the War Dept. The said O.S. No. should therefore be deemed not to have passed to the War Dept. under the within Conceyance.

By Conveyance dated 31 October 1951 and made between (1) the within named H.M.'s Principal Secretary of State for the War Department and (2) The Rural District Council of Andover part of the within described property namely 0.2 of an acre or thereabouts forming part of Inclosure number 187 was conveyed to the said Rural District Council in fee simple and an easement for a water main was granted to the said Rural District Council over another part of the said Enclosure number 187 [Duplicate Conveyance retained].

By Conveyance dated 26 March 195?9 made between H.M. Principal Secretary of State for the WD (1) and the County Council of the County of Southampton (2) part of the within described property namely 0.27 acres in parish of Barton Stacey being OS Pt 55 was conveyed for an estate in fee simple - Duplicate Conveyance retained WOC/3758/JCL.

8 September 18[?5]8: By a Conveyance of this date 3.8 acres of land to west of Roberts Road Barton Stacey together with rights of way were conveyed to the Hampshire County Council [Duplicate Conveyance retained - WOC/3157/BJB].

By a Licence dated 5 February 1960 Arnold Stancomb Wills was granted a licence in perpetuity for a water pipe across O.S. 230 [See WOC/3719/BJB].

Memorandum

By an Instrument of Dedication dated 13 February 1962 made between the Secretary of State for War and Hampshire County Council 5.37 acres of land forming part of Inclosure Nos. 150, 152, 172, 175a and 188 were dedicated to the use of the public. (WOC/4428/MF --?)

Memorandum

By an Agreement dated 18 June 1962 and made between Her Majesty's Principal Secretary of State for the War Department of the one part and Hampshire County Council of the other part it was agreed to dedicate to the use of the public 0.260 of an acre of land comprising parts of O.S. Enclosures Nos. 192, 224 and 224a. (T.S. ref. WOC.4536/LHP).

Memorandum

By a Deed of Exchange dated 20 November 1963 and made between Westminster Bank Limited and Stella Cecilia Mary Kidd of the one part and Her Majesty's Principal Secretary of State for the War Department of the other part a portion of the land comprised in the within written Conveyance being land and the bed of a stream in the Parish of Barton Stacey adjoining or near the Bransbury Mill Estate was conveyed to the said Westminster Bank Limited and Stella Cecilia Mary Kidd together with certain fishing rights and their right to production and delivery of copies of the within written Deed was acknowledged. W.O.170/E/SP File 119/Southern/401[?1].

Memorandum

By a conveyance dated 3 March 1965 between the Barton Stacey Sewage Disposal Works comprising O.S. Field number 93 and parts O.S. Fields numbers 97, 98, 150 on the O.S. map Edition of 1910 together with the sewers and certain rights and easements in respect whereof were conveyed to the Andover Rural District Council and an Acknowledgment given for production and delivery of copies of the within written Deed. WOC 5339/L?RT.

Memorandum

By a Deed of Grant dated 29 July 1971 the Secretary of State for Defence granted to the Andover District Council easements in fee simple for a 6 inch foul sewer across parts of O.S. numbers 220a and 222 (1911 Edition) - duplicate deed retained - DC.3/01/BJB.
